

Privacy Policy

Introduction

This privacy policy applies to www.SynchroCommercials.co.uk. At www.SynchroCommercials.co.uk, we respect your privacy and seek to provide you with a powerful and secure online experience. This policy describes the type of information we gather from you from www.SynchroCommercials.co.uk.com and how we may use or disclose that information.

Types of Information Collected

We collect information directly from you and automatically about you as you use our website. The type of information that we collect about you varies based on your interaction with our website.

Information We Collect Directly From You. In connection with your use of our website, we ask for and may collect a variety of information from and about you in different ways. For example, when you request that we contact you, we may ask for and store your and/or your business's name, address, email address, and other identifying contact data.

Information We Collect Automatically. We, and our service providers, collect information about you automatically through cookies, web beacons, and other tracking technologies as you use our website. Please see "Cookies and Other Tracking Technologies" below for additional information.

How We Use Your Information

We use your information, including your personal information, primarily to market and provide our services to you. In particular, we may use your information as follows:

- **To provide our website and services to you.**
- **For the purpose for which you provided the information to us, such as to respond to your inquiries and to provide information in response to your request.**
- **For marketing and promotional purposes, for example, where permitted by law, we may use your information, such as your email address, phone number, or mailing address to contact you about services or information we think may interest you.**
- **To tailor the content and information that we may send or display to you, to offer location customisation (where permitted by applicable law), and to otherwise personalise your experiences while using our website.**
- **As permitted by applicable law, to assist us in advertising our services in various mediums including, without limitation, sending you promotional emails, advertising our services on third party sites and social media platforms, direct mail, and by telemarketing.**
- **To better understand how users access and use our services, both on an aggregated and individualized basis, to administer, monitor, and improve our services, for our internal purposes, and for other research and analytical purposes.**
- **To protect our customers, employees or property — for instance, to investigate fraud, harassment or other types of unlawful activities, to enforce this policy and our Terms of Use.**

When We Disclose Your Information

- ***Service Providers.*** We may disclose the information we collect from you to third party service providers who perform functions on our behalf. Third party service providers will only process your personal data in accordance with our instructions and will implement adequate security measures to protect your personal data.
- ***In Response to Legal Process.*** We may disclose the information we collect from you in order to comply with the law, judicial proceedings, a court order, or other legal process, such as in response to a court order or a subpoena.
- ***To Protect Us and Others.*** We may disclose the information we collect from you where we believe it is necessary to investigate, prevent or take action regarding illegal activities, suspected fraud, situations involving potential threats to the safety of any person, violations of our Terms of Use or this policy, or as evidence in litigation in which we are involved.
- ***Business Transfers.*** If we are acquired by or merge with another company, or if substantially all of our assets are transferred to another company, we may transfer the information we have collected from you to the other company.

Security of Your Personal Information

www.SynchroCommercials.co.uk has implemented processes in an attempt to protect your personal information from misuse. Your information may be stored and processed in the United Kingdom or any other country where www.SynchroCommercials.co.uk, its subsidiaries, or its third party service providers are located.

Control of Your Password(s)

You are responsible for all actions taken with your User ID and password, if any. Therefore, we recommend that you do not disclose your password to anyone. If you lose control of your password, you may lose substantial control over your personally identifiable information and may be subject to legally binding actions taken on your behalf.

Protection of Children's Personal Information

Cookies and Other Tracking Technologies

We and our third party service providers use “cookies” and other tracking technologies on our website. A “cookie” is a small text file that may be used, for example, to collect information about website activity. Some cookies and other technologies may serve to recall personal information previously indicated by a web user. Most browsers, allow you to control cookies, including whether or not to accept them, and how to remove them. You may set most browsers to notify you if you receive a cookie, or you may choose to block cookies with your browser. The law states that we can store cookies on your device if they are strictly necessary for the operation of this site. For all other types of cookies we need your permission. This site uses different types of cookies. Some cookies are placed by third party services that appear on our pages.

Choice
